VAUCLAIN SELLS 11-ACRE ESTATE


More Than Half Million Paid for "Broad Lawn" —May Be Developed

The Sanuel M. Vauclain estates known as "Brond Lawn," near Newtown Square, were sold on Saturday afternoon for a consideration of mere than \$500,000. The property which extends from Newtown Square to Crum Creek, consists of 1100 acres, and was sold for \$500 on acre. The dept was handled by Benjauda T Levis, of Media and Frank B. Sturdevant, of Philadelphia, white the Philadelphia Trust Company represented Mr. Vauclain. The purclasser of the property was E. C. Von Helfenstein, of Philadelphia, it is reported that Mr. Von Helfenstein intends to break up the 1100 acres and either sell it or develop it.

There is also talk that the property known as the W. P. Thomas "Ashland Furms," consisting of 328 acres, which was owned by Dr. John Agnew before it was purchased by Mr. Vanclain, will be sold and turned into a country club with a golf course, tends courte, swimming pool and riding neadency.

The entire 1100 acres were purchased by Samuel M. Vanelain about six year ago for his daughter Anna, and was used by her for several years as a farm for thoroughbred horses. There are fourteen dwelling houses on the property at the present time and it is estimated that Mr. Vanclain spent more than \$750,000 on the property in the purchase price and improvements since he has had it.
